Volunteers are the absolute backbone of Inn Churches along with our skilled and dedicated staff and management team our volunteers continue to make a huge difference to countless disadvantaged people within our community. Inn Churches volunteers bring great qualities with them and we recognise that they work tirelessly throughout the winter in serving our guests. However, much more than that, they show that they have a heart for the poor. Our winter shelter is run entirely on voluntary donations.

Trustees Annual Report (continued) for the year ended 30 June 2014

Objective and activities

- (a) The prevention or relief of poverty in West Yorkshire by the provision of emergency and other accommodation, advice and assistance for persons in need who are deemed homeless.
- (b) To provide grants, items and servics to individuals in need, or to other charities or organisations working to prevent or relieve poverty, as the trustees see fit.
- (c) To promote the physical and mental health of homeless men and women through the provision of shelter, financial assistance, support, education and practical advice
- (d) To advance the education of the public and volunteers in the subject of drug awareness, homelessness and other related subjects
- **(e)** Promoting social inclusion for those excluded or marginalized from society because of social or economic disadvantage.
- (f) The furtherance of other such purposes as are exclusively charitable under the Laws of England and Wales, as the trustees shall from time to time determine.

Review of progress and achievements

Winter 2013 seemed to come round very quickly. With the winter of 2012 being very cold our aim for winter 13 was to extend the provision of the Winter Shelter. Seventeen hosting churches came on board to support the homeless with each hosting for a week. Four of those for the first time this year.

Inn Churches Bradford provided 1428 bed nights to a total of 112 individual referrals over the four-month period. In addition we were also able to accommodate other guests for a further 30 bed nights in local Bed and Breakfast and our sister projects Inn Churches Halifax and Huddersfield jointly provided an additional 1080 spaces.

We are excited to be part of a project that reaches out to the homeless and vulnerable in our city. The heart of Inn Churches has always been to care for homeless and vulnerable people without taking any statutory funding for the service, to allow us to concentrate of people not figures. Since our pilot project we have grown so much and are able to offer a service, which not only caters to the homeless in winter but also is able to offer support to some of our city's homeless all year round. We would like to thank the churches, our supporters, volunteers and guests without whom Inn Churches would not exist.

Values

Our values are to do it the right way and in an ethical manner and in accordance with our faith Our values will be lived out, everyday, in how we:

Treat one another and how we expect to be treated in return

We will not discriminate against anyone because of their gender, age, faith, sexual orientation, disability, substance misuse and other life choices – and we will provide a listening ear.

Our Shelter

We understand that our guests come from chaotic lifestyles but on balance all our team are volunteers and the safety and welfare for all concerned is paramount. We therefore can only admit guests who are willing to abide by our boundaries:

- 1. Referral only. Guests cannot just turn up at the door.
- 2. No alcohol or illegal substances to be brought on site.
- 3.No anti-social or aggressive behavior tolerated.
- 4. Respect our volunteers.

Volunteers arrive from 5pm to set up and prepare a lovely home cooked meal.

Between 7pm and 9pm is 'checking in time'. Guests are greeted by the volunteers and offered a hot drink before being served their meal. Many churches had table tennis, pool, magazines and games available. Movie nights were also on offer in some churches. Some guests want to sit and chat whilst others will prefer to sleep or relax.

'Lights out' time was officially at 11.00pm.

During the night four volunteers stay on duty and there is an on-call arrangement with the Shelter Coordinator which was needed on several occasions.

At 6.30 -7.00am volunteers arrived for the morning shift and guests not yet up and about were awakened.

7.45 Breakfast

8.30 Doors closed

For four months the winter shelter ran at a different venue each week. Along with our partner agencies we continued to be a vital part of the provision in the City of Bradford for homeless people.

No Second Night Out

The No Second Night Out (NSNO) project was launched on 1 April 2011 as a pilot project aimed at ensuring those in London, who find themselves sleeping rough for the first time need not spend a second night on the streets. We took this premise and, working with other support agencies we aimed to target new rough sleepers, to minimise the risk of them having to spend a second night out in the cold. We identified 27 people for whom it was their first night out on the streets and worked with them to try and get them housed after spending a few days with us. For one man this was working at reconnecting with his family, for another repatriation and yet another swapping his car for a night in our project then into a new home.

Bradford Change Agents, who themselves are funded by the NSNO inititive worked with us to help move guests into accommodation as well. Some guests proved a little difficult to move on, not having identification, passports had been stolen or they had been in the country without having had contact with services so that proving they had been here for the required three months was a challenge.

Although we do not have targets to meet we do keep details of our guests:

112 guests were referred

95 Male

17 of them female

39 were from the EU

2 asylum seekers

2 refugees

11 reported they had been victims of domestic abuse

4 of our guests were supported to move back to their home country with 3 of them being identified as victims of trafficking

Some of our guests were able to move into social housing whilst several managed to obtain places at some of the local hostels. We are also able to find places in private rented accommodation for many guests with some floating support

Recent data collated through Homelesslink shows that providers of services for the homeless are facing increasing demand. This is in a time where they face budget cuts and access to fewer resources to provide support and accommodation for their clients. The recent recession, high unemployment rates, benefit changes and reduced funding contribute significantly to the possibility of increased homelessness. These factors are also undermining people's recovery from being homeless.

Agencies in Bradford have been working to help support the homeless and look at solutions to providing support for complex needs.

One of the key areas that Inn Churches found a gap in provision was working with those vulnerable adults with complex needs. We were unable to allow them access to the project because of their offending behavior or high substance misuse. However, it is evident that these clients present a greater risk on the streets than a majority of those who we sheltered. Provision for them was minimal and they were refused access to a majority of services causing a spiral of depravation. This year we found ourselves with higher risk quests and dealing with those with complex needs. (so occurring psychiatric substance and chronic medical

risk guests and dealing with those with complex needs. (co-occurring psychiatric, substance and chronic medical conditions or offending behaviours) We found 98% of guests presented with health needs and 13 had learning difficulties.

Guests comments

You have no one to turn to, that is the thing about being homeless you don't know who to trust. One minute they are your friend when you get your giro, next thing they don't want to know. I feel angry and upset all the time I always feel like crying. Coming here made a world of difference. **WS**

People don't understand they just think dirty junkie, they don't know what it feels like to have to sleep outside every night. Be spat on and called names. I feel safe here. **JT**

It is good, the organisation is good breakfast good. All homeless people no problem but sometimes noisy. Evening food very very very good. **Stefan**

Without a shadow of a doubt I have been truly moved by the wonderful people on this project. They have transformed my situation which was desperate and I cannot praise anyone highly enough. There are simply no words that can be written that express the commitment of the volunteers or the work that they do. Thanks with all my heart. **JR**

You haven't got enough of your own space. Very very greatful for the help and the food is good. Sometimes the staff is noisy. I get on with the Polish but I don't understand them but I have no problems with them. **JS**

Most churches have good food and a wonderful welcome. But could improve the volunteers to be trained to speak quietly at night.

You have given me Hope......for the first time in ages I have real Hope.......KS

I am blown away by the spirit of generosity and the love I felt here. I was beginning to think this was the end...now I hope there will be a new beginning. TR

Report from Housing Justice

Excellent Practice

Overall Experience – Meeting Juli at the Inn offices was very informative. I was impressed with the unique system they have in place for gathering and maintaining relevant information on both the volunteers and guests.

Admissions – Very sound Referral Procedures in place, I was very impressed in the relationships Inn churches have fostered within the homeless sector and how they work together on ensuring the right guests are referred and supported.

Guest experience – Overall the guests seemed very relaxed, comfortable and had an awareness of the rules within the shelter

Staff and volunteers – The staff show great care and commitment in running a stand-alone project within Bradford. I cannot speak highly enough of how Juli and the team have developed such a well-resourced and respected charity in a relatively short space of time. I enjoyed spending time with the volunteers who showed

good humour and warmth to all the guests.

Communication – Inn Churches have good solid links within the Bradford homeless sector which has resulted in relevant guest information shared between all. Also volunteers are kept updated on shelter news via a newsletter and regular get-togethers (all very impressive). **Thank you** to all at Inn churches; a great project that really cares and is a pioneer of this work in and around Bradford

Starter Packs

Part of the work we do at Inn Churches, working with partner agencies, is help our guests with their move into a tenancy. They are often going through a difficult transition period with very little or no support, and having a starter items helps make their move into independent living in a house or flat much less of a struggle.

The guests we help have come from difficult and often chaotic backgrounds, but with support they can overcome the issues of their past and make a success of their new lives. By providing household essentials such as crockery, towels and bedding, starter packs can help turn their house into a home.

We have been very grateful for funding from **Yorkshire Building Society** in helping to set up this part of our project, **Joseph Rowntree and Unitd** for their support and for the **YBS Charitable Trust** for their further sponsorship. We are also pleased to receive funding from the governments **Warm Homes Healthy People Grant**

WHHP

Inn Churches once again delivered practical support for the WHHP program through a range of interventions and financial support to Food Banks and feeding projects.

The proposal was to provide practical support to people living on a low income and struggling to afford to keep themselves warm and well. The start date was early December until the end of March 2014. Once again not knowing if there would be funding but knowing there would be significant need we requested support from our volunteers and the wider community over autumn period and once again they were massively supportive:

UnLtd donated 80 Food Parcels

Age UK donated knitted items

Feversham Girls School made up 50 Boxes of "goodies"

Inn Churches volunteers donated toiletries and chocolates

Giggleswick School donated 36 duvets

A donor donated 30 new blankets

Participate projects enlisted their contacts and supported WHHP with duvets, hot water bottles and winter clothing.

Through the knitting groups and Homeless Beanies we received over 300 knitted hats.

Bradford Lions donated 20 large food parcels

Most of our referrals were received via First Contact to which our Winter Angels responded with Food, bedding and clothing vouchers. We estimated through the food parcel make up that this reached over 1400 individuals with some families having up to eight children. Two and a half tons of food was delivered in the Bradford area alone.

36 bedding sets were purchased and 12 camp beds for the Inn Churches homeless winter shelter where we provided 1536 bed nights for 112 homeless men and women.

Part of the funding bid was to support other projects working with the homeless and both Hope Housing and Inn Churches were able to use some of the funds to assist rough sleepers to gain private accommodation by paying a first months rent in advance.

16 guests of Inn Churches were given support to move into permanent accommodation by putting down a deposit/bond for them.

We extended the support of the The Little Blue Shop at Forster's College continuing to channel donations received of approximately £2,500 of saleable goods from donations from our volunteers. We distributed vouchers to local agencies who, when they came across a client in need could send them with a voucher to receive practical support. Forster's also gave out starter packs to vulnerable clients who were moving into a new home. Over 180 vouchers were redeemed for clothing and household items. This was commended by last year's evaluator as being an excellent use of resource, which offered choice to the clients.

We worked with Living Lights who continued to distribute to Keighley on our behalf. They had also developed a Foodbank since last winter and referred people into the scheme as well. Bradford Central Foodbank and the Metropolitan Foodbank received funds from WHHP to support their work, as did the Joshua Project and St John's Great Horton to provide local people with Food parcels. We also helped Bradford Lions with their food bank plans and they opened a food bank in BD9 in March.

Inn Churches on behalf of WHHP hosted three BIG winter lunches the feedback from all was very positive and attracted groups from a range of areas. The first lunch hosted 50 people, the second 95 and the third 95. The aim was to reduce isolation and to encourage agencies to showcase their work in an informal setting. Carers Resource, Self-Help, Homestead, The Cellar project Creative Support and Hale all came along to support the event.

Bus tickets were purchased to allow clients to attend appointments.

Health needs:

One of the more satisfying aspects of WHHP is feeling that we really make a difference in the lives of our clients. For the Inn Churches WHHP referrals Carers Resource have isolated the data to show which of the applicants presented with a health need.

Some of the illnesses experienced by the clients were, arthritis of spine, nerve damage, asthmatic, chrohns disease, severe burns to feet, epilepsy, breathing difficulties, COPD, emphysema, fibromyalgia, angina, Addison's, Stroke, chest infections, bronchitis, MS,

As we have funding from the NHS for a welfare manager we were able to use some of her capacity to support several clients via WHHP.

The first gentleman was referred for food parcel and gas/electric top up via WHHP. When we made contact he told us his circumstances and we felt he needed a longer-term provision of support, as he was not in touch with any other services, which he agreed. We contacted DWP and requested that the deductions from his ESA payment were reduced to a lower amount. We assisted him to attend a benefit tribunal, which he won, we assisted him to obtain a concessionary bus pass, and we assisted him to access debt advice @ CAB. On one occasion he was very poorly and we liaised with his GP surgery to do a home visit. He also had a spell in hospital; we visited him, as he has no family in the area. With Jo's intervention his circumstances have much improved and he knows he has support when he needs it, which has greatly helped his mental health.

We received a request for food parcel and quilt, via WHHP. We contacted the gentleman asking questions with regard to his circumstances and it transpired he had a range of support needs, benefit advice/assistance/debt advice/signposting to services to reduce social isolation. In addition he also had a recent terminal diagnosis. We have been working with him for a number of weeks now, he is working with CAB for debt advice, we have completed benefit applications and assisting him to find groups that he can join.

This support has been very helpful to him, as he has fallen so behind on his mortgage he was at risk of loosing his home. With the debt advisor's help and Inn churches help to maximise his income he may be able to remain in his home. We are also working with his daughter who is his carer, helping her to access carer's support and benefits that she was not aware of.

A lady we visited to give a food parcel and electricity top up was in a desperate state. Her home in a privately rented house was so damp it ruined all her furniture. Her three children were forced to sleep in one room for warmth and beds and bedding were covered in mildew. This had an adverse effect on their health. The lady was a single parent and was working part time. The landlord was not forthcoming in helping with the property so Jo took her to view other places. With a small deposit from WHHP she now has a suitable property fit for her needs.

Others said of the project

- "I was really pleased with the help I received it was just what I needed."
- "I have a problem with my benefits so this really helped"
- "I have got 4 children 2 of whom had autism so this helped relieve the stress"
- "I had help last year too so I was looking forward to the food parcel"
- "Once I got over my pride and asked for help it was great to know people cared"

There are a wide range of risk factors that combine to make people more vulnerable to becoming homeless. Many negative views of homelessness would site alcohol and drug misuse as the main factors. However, financial, mental health, and family breakdown issues, as well as leaving prison and a lack of recourse to public funds are also key factors to the homelessness experienced by the guests of the Inn Churches Project this winter. The groups most affected by homelessness in Bradford seem to be single males, EU migrants and asylum seekers, many of those through family and relationship breakdown. In the short period of time we were operating, we also witnessed repeat homelessness amongst certain categories of guests.

The recession brought with it a whole new series of problems. Prior to the recession decent affordablehousingwasalwaysanissue. Manyfamiliesarenowstrugglingtocometotermswith debt, unemployment and housing. The forthcoming benefit cuts, whilst being delayed are still of concern to the most vulnerable in our city and the agencies who work with them. The next few years could see the situations faced by our guests worsening as relationships and health suffer with the impact of these cuts.

Bradford is very fortunate to have some very well-established networks and food provision. Many of our volunteers were people already involved in working with the homeless and the churches were in a good position to respond to the needs of our guests at a grassroots level. There was also a greater flexibility that allowed for some situations and needs to be quickly addressed. The project was a fantastic witness to Bradford of the faith we have in Jesus Christ that speaks about reaching the lost and overcoming injustice.

Although not without some problems, the more we continued with the shelter and worked with those most vulnerable in our society, the more we realised that this was a necessary project we were providing.

27 had no problematic alcohol & substance issues identified at the time of referral

24 were identified as having mental health issues or learning disabilities.

98% of our guests presented with some form of health problem most were able to get into more permanent accommodation directly from the Winter Shelter

5 others were known to be in other accommodation before the end of our project

3 were found to have been the victims of human trafficking

2 have been able to get into rehabilitation for substance misuse

Monitor progress of our guests.

Set up a Winter Shelter project plan to track tasks and progress.

Build on the networks we have already made to strengthen

Secure funding.

Attend meetings by Shelter, Homeless Link and Bradford CWP.

Hold discussions with police and local councillors.

Seek advice from the local fire officer.

Carry out Risk assessments on any premises used.

Hold meetings with local agencies to ratify referral processes and train volunteers.

Keep themselves informed of current trends, policies and good practice pertaining to homelessness in Bradford.

"Coming here has given me a sign of hope – it's been a godsend. These volunteers might not have been through what I've been through, but they're people that care."

It is apparent that there will always be a significant proportion of those accessing homelessness services who, for a variety of reasons, are not at a stage in their lives were they are willing or able to engage with services to address underlying issues or root causes. For this group the Shelter provides a no-obligation service, which offers a place of safety until such times as individuals are willing to take the necessary steps to "move up the ladder". In this, the Winter Shelter provided an invaluable and potentially life saving service.
