Our Objectives

The prevention or relief of poverty in West Yorkshire by the provision of emergency and other accommodation, advice and assistance for persons in need who are deemed homeless.

To provide grants, items and services to individuals in need, or to other charities or organisations working to prevent or relieve poverty, as the trustees see fit.

To promote the physical and mental health of homeless men and women through the provision of shelter, financial assistance, support, education and practical advice.

To advance the education of the public and volunteers in the subject of drug awareness, homelessness and other related subjects

Promoting social inclusion for those excluded or marginalised from society because of social or economic disadvantage.

The furtherance of other such purposes as are exclusively charitable under the Laws of England and Wales, as the trustees shall from time to time determine.

Progress review

Year ending 30th June 2018

2017/18 flew by so quickly, but was another productive year for us. From Lloyds Bank Foundation funding we were able to access support from a wonderful mentor called Helen Middleton, which has helped us to consolidate and refocus our time and energy on what we do well. As we prepared this report, we were astonished to realise that we had worked with over 100 community groups, churches, statutory and third sector organisations this year. We are, as always, humbled and heartened at the number of people we have been able to support, through the tremendous generosity of our supporters, donors, volunteers and funders.

We are hugely grateful to the volunteers without whom we would not be able to function. From our dedicated team who help to run the café throughout the year, to our army of Winter Shelter volunteers, to those who help to manage the warehouse and process food donations, to the teams who come in to tackle particular jobs and tasks.

In particular we continue to be very grateful to the Yorkshire Building Society who have sent frequent volunteering teams to help cook, clean, decorate and help out wherever needed. We also thank Torque Logistics for donating large amounts of racking for our warehouse, Teconnex Ltd who made a large donation towards our Suits on the Streets appeal, and Bradford Bronte Rotary Club who have funded an extension to our outdoor decking area.

This year we said goodbye to our Warehouse Manager Martin as he stepped down to take care of his wonderful Mum. We have been so incredibly blessed to have had Martin's skills and eye for detail in developing the food side of our project. Thank you Martin. We also welcomed Soraya from Jamie's Ministry of Food who has stepped in to be our Welfare Manager. She has brought with her for a transition period Andy Laidlaw. We are excited to see how working together can strengthen our offer to communities.





Winter Shelter

Our ninth Winter Shelter has been an amazing season wonderfully supported by the generosity, welcome and love of our host churches and volunteers. Our guests have been given practical support, the hope that comes as we've supported many into permanent accommodation and the unswerving love provided by the Inn Churches family.

A striking feature of this year's shelter season has been how prevalent the struggle with acute mental health issues has been amongst our guests. Because of the amazing person-centred response our team has providing when dealing with mental health we have intervened in more crisis situations and been able to provide additional support. We are extremely grateful to all of our team for going the extra mile to find solutions in these crisis situations. We could tell many stories of guests finding their way through seemingly impossible situations: they have been our inspiration and continue to be our motivation to carry on.

We could not provide this service without the help of our volunteers who gave nearly 6,000 hours of their time freely and willingly on the Winter Shelter alone, to whom we say a huge thank you. This year we welcomed First Martyrs Heaton and St John's Great Horton as host churches, and continue to be very grateful to Bevan Health Care, who run a street doctor service at the shelter and to Prashad, who offer a delicious vegetarian curry for our guests each week.

As usual, the winter started with our annual memorial service at the cathedral, where we read out the names of the people who have died after being homeless. It is always a moving reminder of why we run our winter shelter.

Our winter shelter provides 12 beds for 16 weeks in the coldest months of the year (December to March), in a different partner church each week. Unlike many hostels, some beds are for those with 'no recourse to public funds' - for instance failed asylum seekers, people who've been trafficked, or partners of those with residency rights whose relationships have broken down. Churches provide guests with a hot meal each night, breakfast each morning and a bed for the night in between. But guests also get support: from simple conversations with people who listen, to help finding and keeping longer-term accommodation - which is why we limit our beds to twelve.

We continue to work with Housing Justice to share best practice and to support the network of shelters across the UK. We are also part of Bradford Council's cold weather provision (CWP), which provides beds when a sub-zero temperature is forecast. This year the CWP provided 377 bed spaces to 150 guests over 50 nights, 67 of whom were moved into longer term accommodation.

This year we were mostly without a permanent Welfare Support worker, with nearly every team member stepping in to provide support in different ways, assisted during the Winter Shelter by our former welfare worker, Dan.

Warm Homes Healthy People

This year the Warm Homes Healthy People (WHHP) service was moved to a new referral and recording system, which means that we only have partial records, something we have now put better recording systems in place at our end to prevent happening again. Since January, when the new system was launched, 609 people were referred by an agency, friend or themselves. Of those, 65 sought our provision of practical support in the form of bedding or food parcels. This is a lower figure than in previous years, possibly partly due to the new referral form having more options to choose from, and possibly due to generally lower promotion and awareness of the service.

Starter Packs

We provided around 50 starter packs to people moving from the streets into tenancies, containing essentials such as crockery, towels, bedding, a kettle and basic food supplies.

Acts 435

The Acts 435 service connects people with specific (and usually urgent) financial needs with donors who would like to support them. We are able to post requests for items costing up to £120 such as fridges, washing machines, kettles, microwaves, crockery, curtains and carpets. Individuals accessing the site are then able to donate towards these specific items until the need is met.

This year generous donors enabled us to support seventeen individuals to purchase essential household items which they otherwise had no way of obtaining. This has been really helpful in enabling people to move into their own homes, setting themselves up with the goods necessary to sustain their tenancies - with referrals coming from numerous voluntary and statutory services in the Bradford area.

We were blown away this year when a generous donor got in touch with Acts 435 and donated over £2,000 to help an individual who had lost everything when their house was destroyed in an arson attack.

Homeless Beanies

For many years, Homeless Beanies has been a small but valuable independent enterprise based around a simple idea of 'paying it forward' - buy a donated beanie and we supply a second beanie to somebody who is homeless.

Thanks to funding and mentoring from the Lloyds Bank Foundation, we have been able to bring Homeless Beanies fully into the Inn Churches family and to begin to develop it as an enterprise hub that aims to provide opportunities for people who are homeless, newly or vulnerably housed or long-term unemployed to learn, earn and work their way out of poverty.

The aim is to provide support for people to set themselves up as self-employed, either within a Homeless Beanies enterprise or developing their own small business idea.

Each Homeless Beanies enterprise will be run and staffed by homeless, recently or vulnerably housed or previously long-term unemployed people, supported with the appropriate training. They will work on a franchise model, with each being self-funded and sustainable. Furthermore they will be designed to generate a profit for re-investment into the scheme. We are planning to work with industry partners to provide their expertise in training and mentoring as part of their corporate social responsibility.

In our first development year we have focused on four areas:

- 'Beanie buddy' mentors: we have put in place a training scheme and structure for our mentors, and developed resources to help them mentor prospective workers.



- Homeless Beanies Knitting: we have taken the original Homeless Beanies idea and redeveloped it as our first 'model' social enterprise. We have worked with National Citizen Service students to begin to develop the range, and begun to recruit volunteer Beanie Reps to widen the sales avenues.
- Homeless Coffee Beanies: our second social enterprise aims to sell 'good coffee for good reasons'. We've partnered with The Barn Coffee House at Meanwood Valley Urban Farm to develop mobile Coffee Beanies carts and to train people as Beanie Baristas, with profits split between the Baristas and Homeless Beanies. This will allow people to earn money, as well as being trained with transferable skills. Profits coming back to us will be re-invested into growing the franchise. We've also partnered with Shiloh Coffee Roasters to develop a bespoke coffee blend which we are distributing to churches, businesses and other customers, serving in our café, and will be sold on the road through the coffee carts.
- Sustainable solutions: part of our support from Lloyds Bank Foundation has been the opportunity to consider the best approach to take in working alongside vulnerable people, to develop a sustainable and supportive model which can be scaled and replicated, and to work 'alongside' those we are trying to support, not doing things 'to' or 'for' them. We've also been encouraged and mentored in applying this approach across all of our work as a charity, and in really working on our structure, practices and strategy to ensure that Inn Churches as a whole .



Cooking @ The Storehouse

This year we had the opportunity to complement our provision of food to projects across Bradford with a programme of food education and awareness.

Many of the groups and communities we work with have identified food poverty as a key issue and our new Cooking @ The Storehouse project enable us to help people to feed themselves well whatever their situation or budget – with all the health and social benefits that brings.

We are now working with schools and community groups across Bradford to deliver hands-on cooking workshops, including the highly-respected Jamie's Ministry of Food community cooking classes, giving people hands-on cooking experience, along with friendly advice on recipes, ingredients, shopping and nutrition, local and seasonal food.

We welcome Soraya, who has been running Jamie's Ministry of Food Bradford for the past eight years, and her colleague Andie to our team to deliver the Cooking @ The Storehouse work with schools and community projects across Bradford.

Soraya says,

"We're very pleased to be joining Inn Churches to continue to deliver excellence in activities promoting healthy eating. We take huge pride in our work and are passionate about educating and empowering people to feed themselves healthily, and working from The Storehouse will enable us to extend and develop our work."

Food Hub and Café

This year our food hub intercepted just over 92 tonnes of surplus food that would have otherwise been discarded - worth around £155,000 at industry standard retail value (and which would have cost at least £9,500 for companies to send to landfill). We redistributed it to 42 different community groups, contributing to 220,000 meals, as well as through our pay-as-you-feel café.

The Storehouse Food Hub is not a food bank: our food is distributed through community organisations across Bradford (some of whom are food banks). Some collect food from us to provide community meals, or meals as part of their activities (for example afternoon snacks for a children's activity project, a lunch club for the elderly), some take one of our pre-prepared mini markets which make fresh food available to on a pay-as-you-feel basis to those who wouldn't otherwise be able to afford to eat healthily.

Our partnership with FareShare continues to see them providing a distribution point from our warehouse on a Thursday, enhancing our offer across Bradford and significantly increasing the amount of food being distributed to organisations across the Bradford District.


The café has been quieter during the day over the past year but we have run a much larger number of events there and its reputation as a meeting place is growing. We have a small number of very committed volunteers but would like to grow this team, with a view to opening the café five days a week when resources allow.

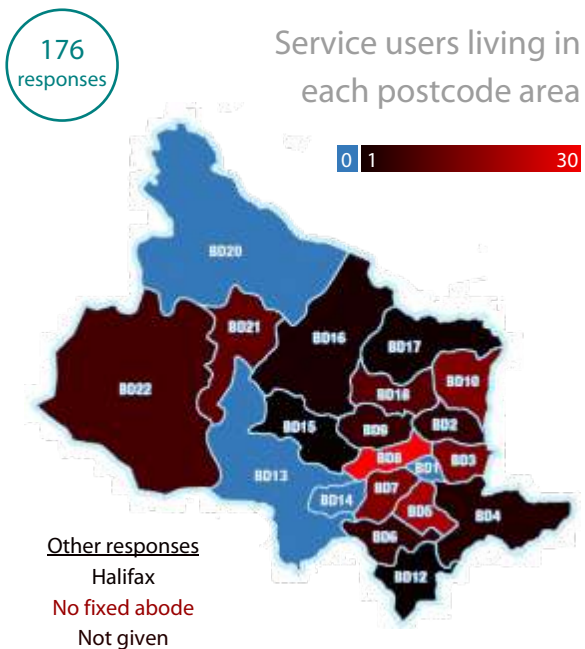
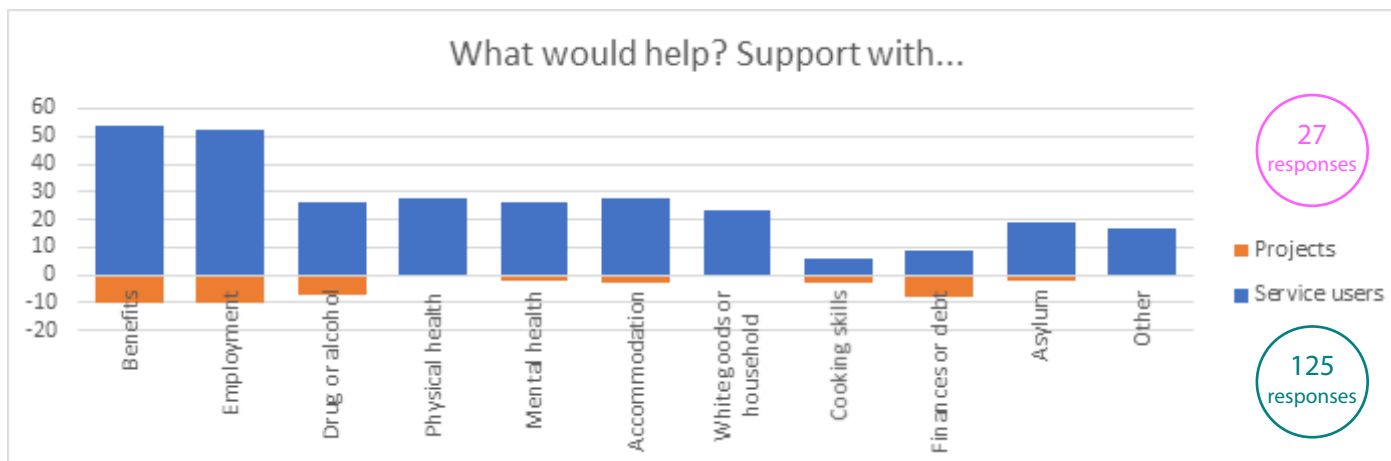
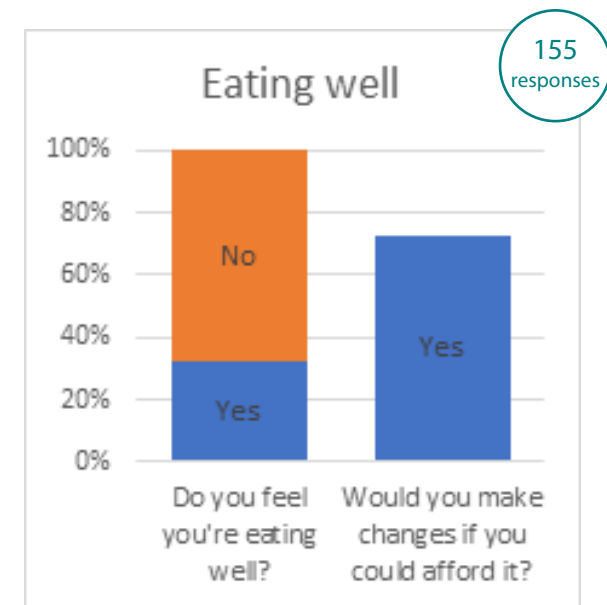
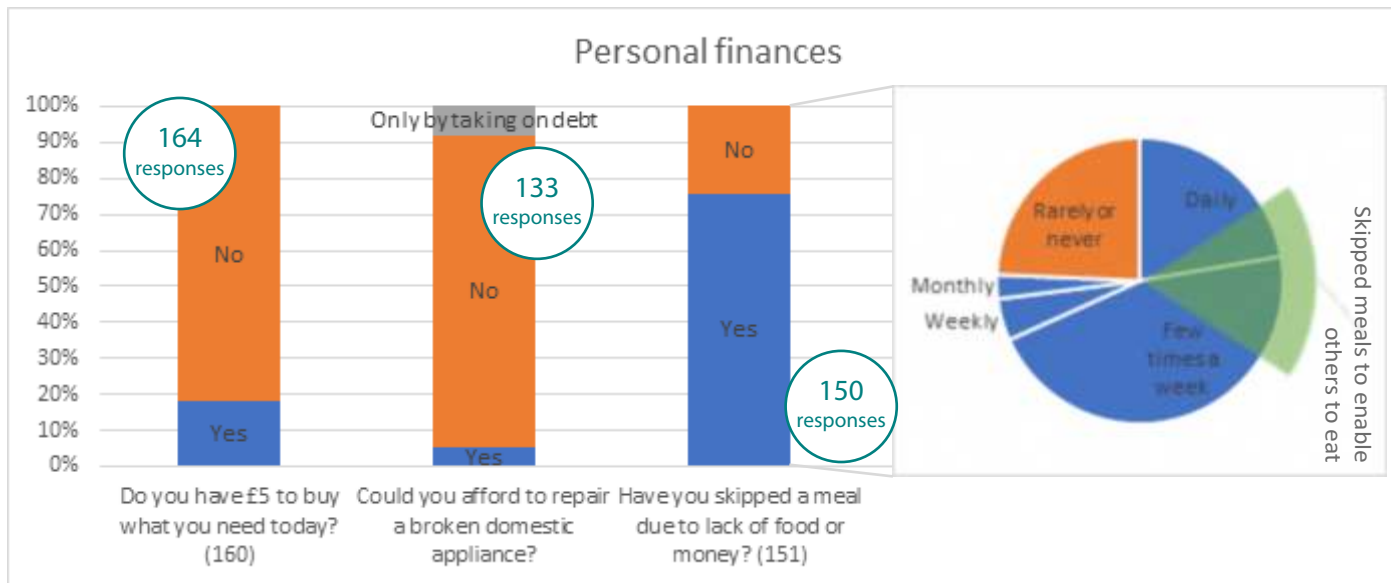


Feeding Bradford

We are proud to be part of the Feeding Bradford initiative, bringing together organisations tackling food poverty across Bradford to be more strategic about the provision we are able to make. Feeding Bradford undertook an initial research exercise to assess the current food provision across the Bradford District, with questionnaires completed by 43 projects across Bradford, and by their service users.

Events

In particular our volunteer thank you evening in April allowed us to thank a full café of wonderful volunteers with a delicious meal of intercepted food, outstanding live music from our friends The Nigel Passey Band and The Dunwells, and chocolate treats donated by Marks and Spencer.

Suits on the Streets

Our annual Suits on the Streets event saw 30 people sponsored to spend a night 'under the arches' just outside Bradford Forster Square Station.

We are really grateful to all the individuals and groups that took part, in particular Liz Ford and Accent Housing who have supported the event for many years.

The event raised £8,500, all of which will go towards our winter shelter costs. Thank you to every one of our Suits - and to everybody who supported them.

Charity of the Year

We were delighted that both the Bradford Belles Women's Institute and the Bradford Bronte Rotary Club have chosen to continue supporting us as their charity of the year.

Bradford SOUP

We continued to partner with Bradford Bronté Rotary Club to run Bradford SOUP, an initiative aimed at supporting local projects making a difference. At each event, entry to which is by donation, people pitch ideas for improving our city and participants vote for their favourite. All donations are divided amongst the projects based on the votes.

We have now run nine events and raised £4,000 for local projects, including groups working with mental health, community arts, sanitary health, people who are homeless, carers, people with disabilities, working class communities, inner city children, hearing-impaired young people, refugees / asylum seekers, families of cancer sufferers, and isolated women.

Jonny Walker

23rd July 1980 - 14th March 2018

Jonny Walker, our wonderful friend and Patron of Inn Churches, died on the 14th of March 2018.

Jonny was a Liverpool-born street entertainer, campaigner, professional musician and all round nice guy. His family posted:

"It is with great sorrow but immense thankfulness for a passionately lived life, that after three days in the Critical Care Unit at Leeds General Infirmary, Jonny died peacefully, at 11:13am today, surrounded by family."

Jonny loved his work and the people in his world clearly loved him. He was passionate about what he did with us at Inn Churches because it was an extension of his ministry on the streets, healing the lost and the lonely. Juli writes,

"I first encountered Jonny in 2008, where he played my request for Romeo and Juliet but it would be couple of years later, when I met him personally, he soon became a close friend. He was honoured when I asked if he would consider being a Patron of our charity but truly the honour was all ours.

If Jonny was a stick of rock, kindness, goodness and sweetness would be the words running through him. He was a beautiful whirlwind, sweeping into our café, often late, always hungry and then he would pick up his guitar and pour out love and light. Jonny's free spirit was all-inclusive, opening his heart and arms to the sick, the lost, the vulnerable and the lonely and treating them all with dignity and respect. But woe betide the hecklers as he had some very witty comebacks.

The family had such an outpouring of love with cards sent here to Inn Churches, words of condolences, there were literally thousands of people who were touched to the core by Jonny's beatific smile, gentle spirit and loving ways. People talking of how Jonny saved their life, put them on the right path, acknowledged their pain or gave them hope to carry on.

Along with his music, Jonny's greatest joy was his family. A wonderful brother, father and friend, he delighted in his children. For us, Jonny was the epitome of of Hebrews 13: Be not forgetful to entertain strangers: for thereby some have entertained angels unawares.

But who knew all along, it was us entertaining an angel. Goodnight and God Bless Jonny.



Results for the year

Total income for the year was £186,862 (2017: £156,209).

Total expenditure for the year was £177,775 (2017: £169,385).

Net income for the year was £9,087 (2017: £13,176 net expenditure).

Net assets of the charity at 30th June 2018 were £89,427 (2017: £80,340).

In this year we brought the accounts of Homeless Beanies into those of Inn Churches, resulting in a one-off income of £819.

We also fixed a reporting error, where unrestricted funds were being reported as restricted, resulting in a transfer between funds of £2,320.

1. Accounting policies

Basis of accounting

The financial statements are prepared under the historical cost convention and are in accordance with Charities SORP (FRS 102) (effective January 2015).

Funds held by the charity

Income and endowments

All income and endowments are included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Expenditure

Expenditure is accounted for on an accruals basis and provision is included in the financial statements for all known liabilities at the Balance Sheet date.

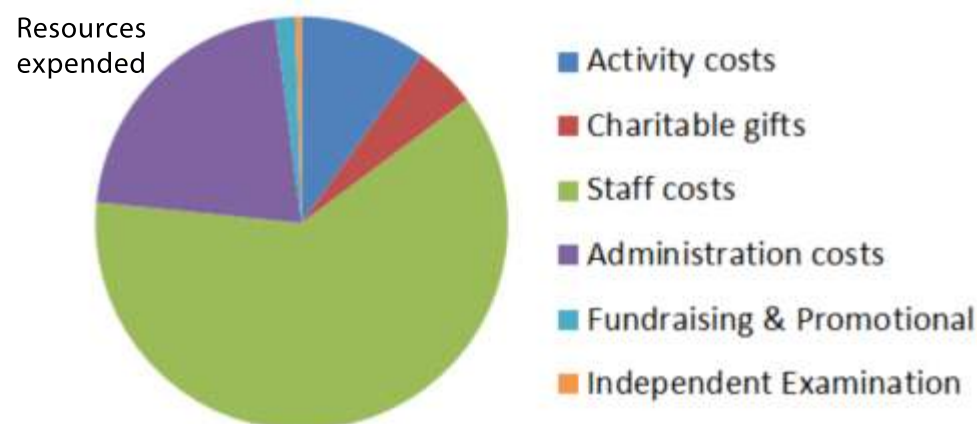
Irrecoverable VAT is attached to the specific expense incurred.

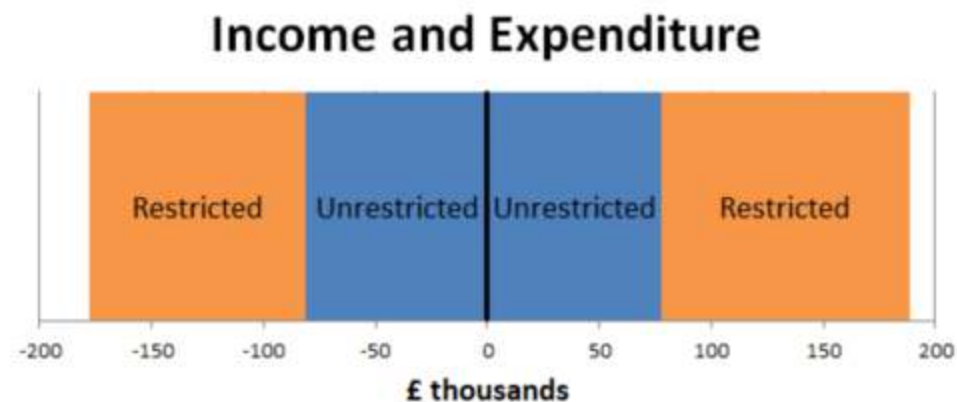
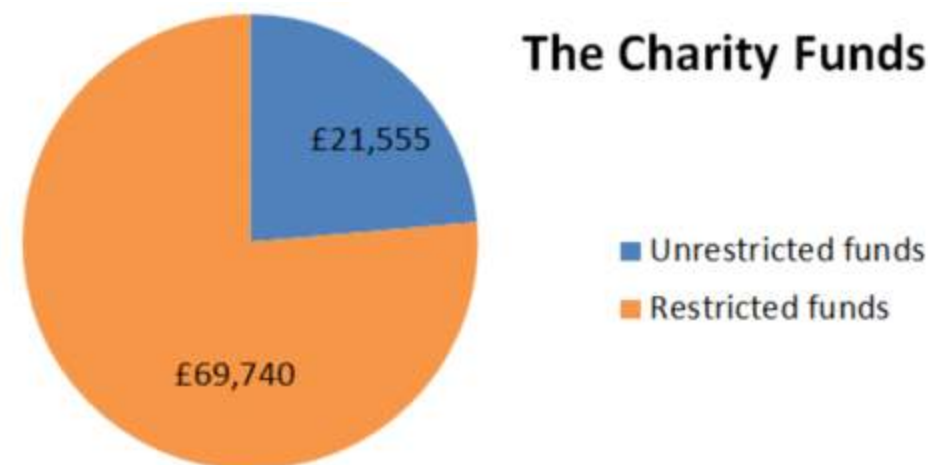

Independent Examiners' Report to the Trustees

We report on the accounts of the Charity for the period ended 30 June 2018, set out on pages 20-23.

Respective Responsibilities of Trustees and Examiner

The charity's trustees (who are also directors for the purpose of company law) are responsible for the preparation of the accounts. They consider that an audit is not required under Section 145 of the Charities Act 2011 (the Act) and that an independent examination is required. It is our responsibility to:

- examine the accounts (under section 145 of the 2011 Act)
- follow the procedures laid down in the general direction given by the Charity Commissioners (under section 145(5)(a) of the 2011 Act)
- state whether particular matters have come to our attention.

Basis of Independent Examiner's Report

Our examination was carried out in accordance with the general directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records.
